



## Home School Agreement Bird's Bush Primary School

By working together, we can help your child be the best



### The school will aim to:

- Provide a broad and balanced curriculum and meet the needs of each child.
- Keep parents/carers informed about school activities
- Inform parents/carers of any concerns affecting their child's work or behaviour
- Inform parents/carers about their child's progress at termly meetings and provide a written report annually
- Encourage mutual respect between pupils and adults
- Provide appropriate home learning activities to support learning
- Care for the safety and wellbeing of each child

### The 'family' will aim to:

- Ensure their child attends regularly and is brought into and collected from school on time – 8.45am (doors open at 8.35am) -3.15pm (School closes at 1.45pm on a Friday).
- Inform the school of any concerns or problems that might affect their child
- Support the school's behaviour policy and provide a positive role model to your child
- Attend parent consultations to discuss progress
- Support home learning activities
- Provide the appropriate school uniform and suitable PE kit for school each day.
- Communicate any concerns or issues directly with school so that things can be sorted quickly

## Conduct Onsite

All visitors are expected to treat staff and children in a respectful way when on any of our sites. Any threatening, abusive or violent behaviour against any staff member or child is taken extremely seriously. Examples of such behaviour are below:

- Shouting at staff, pupils or other parents
- Raised voices
- Swearing
- Intimidating staff
- Rallying other parents to become involved in intimidating behaviour
- Publically voicing unsubstantiated claims about staff, children or the Academy.
- Using homophobic, racist or sexist terms
- Using violence
- Taking alcohol or drugs on the premises
- Willful damage to school property
- Theft
- Threats or threatening behaviour

This list is not an exhaustive list but seeks to provide illustrations of such behaviour that is not acceptable in our schools.

Anyone behaving this way will be asked to leave the premises and the Police will be called if verbal or physical harassment occurs. If necessary action will be taken to ban anyone behaving such a way from the school grounds.

We ask that any issues or concerns are raised with us directly so that we can sort things out promptly and in the best ways possible. We have a social media page to celebrate achievements, ask questions and share information. Please do not post concerns on Social Media, this can result in incorrect information being shared and can make situations worse. The best way is to talk to us directly.
